General

[What is CBD? Where does it come from?](#)

CBD or cannabidiol, is the second most prevalent compound found in cannabis. CBD derives from the hemp plant, which is akin to marijuana but has much less THC and does not cause you to feel high. The natural substance may be used in oils, topicals, or edibles to provide relief, relaxation, and comfort.

[How does CBD work?](#)

Research surrounding CBD is still ongoing; however, we know that CBD influences receptors in your body that are part of your endocannabinoid system, impacting your appetite, sleep, mood, memory, and many other areas.

CBD positively influences receptors throughout the body to help bind endocannabinoids, resulting in many anti-inflammatory, anti-pain, and anti-anxiety benefits.

What is the difference between CBD & marijuana?

Hemp and marijuana are both cannabinoid compounds of the Cannabis Sativa plant, making their molecules look similar, but they are very different. (There are over 85 known cannabinoids.) However, they each have a unique genetic profile. While marijuana has high amounts of THC that may cause you to feel high, hemp has higher CBD and only trace amounts of THC. All Legal Green CBD oils are derived from hemp, allowing you to reap the benefits of cannabis without feeling intoxicated.

Will CBD make me feel high?

No. All Legal Green's products derive from hemp that contains less than .3% THC, so there is no intoxicating effect.

Is CBD oil legal?

Yes. In 2018 changes to the U.S. Farm Bill legalized the commercial cultivation and sale of hemp under specific regulations.

Still, the FDA does not support selling CBD products that claim to cure or treat disease or illness.

What is the best way to consume CBD?

Each method has various levels of absorption, and everyone is different. Some people prefer to ingest CBD topically, while others prefer to vaporize it.

Your preferred method will depend solely on what you're looking for in a product and your lifestyle. Our products are available in a wide variety of forms. We offer CBD oils, gummies, vapes, lip balms, and more.

Will I fail a drug test if I take a CBD product?

All Legal Green CBD products are American-grown, are made with high-quality industrial hemp, and only contain trace levels of THC (below .3%). But to be on the safe side, we advise that you refrain from using CBD products when preparing for a drug test.

What are some benefits of CBD?

The benefits of CBD vary, with some consumers noting healthier sleep cycles and others describing a relief from pain and anxiety. Overall, our customers use CBD products to live a healthier life. Although not designated by the FDA as a health product, numerous studies have

shown CBD's various health benefits. Legal Green CBD products do not claim to treat, cure, or prevent disease. As with any supplement, please consult your physician before use.

Can I use CBD for cooking?

Of course, you can add CBD to salad dressing, pasta sauces, soups, and savory dishes. You can even add CBD to baked goods and sweets. Keep in mind that the compound will degrade at a heat of more than 165 degrees Fahrenheit.

Is all CBD the same?

No, not at all. CBD can be full-spectrum or isolated, raw, heated and filtered, or even converted to a water-soluble compound, all of which produce a different CBD product that impacts your system in different ways.

How do I know how much CBD I need?

See the label of each product for the suggested serving size. Keep in mind that everyone is different. Please use your judgment as CBD is an oil-based food product, and excess oil may upset your stomach.

Do you need a prescription for CBD oil?

No, you do not need a prescription to purchase CBD oil with less than 0.3% THC. All Legal Green CBD products are considered food or supplements and not drugs.

How long does CBD oil stay in your system?

CBD oil may remain in your blood for up to five days after consumption, but the effects don't last long. Results, however, can vary. For some, it may stay in your system for weeks. The amount consumed, frequency of use, manner of consumption, diet, and lifestyle each have an impact.

Will CBD interact with other medications?

Anything that you add to your system could interact with prescription medications. Please consult your physician before use.

I'm taking CBD - why isn't it working?

The amount of CBD that you're taking may not be enough, or you may need to get on a consistent intake schedule. There is no one size fits all. Gradually increase your daily consumption until you reach the desired effect. If you're unsure if it's working, stop taking CBD for 7-10 days to see if it's working. This break will give you enough time to assess if there is a difference.

What are the side effects of CBD?

CBD may have a slight sedative effect, even in small servings. Nausea and gastrointestinal issues are the most common side effects, leading to vomiting, diarrhea, dizziness, and other digestive problems. These side effects are common with oils and supplements.

Also, many products have other ingredients that can cause sensitivity. Be sure to read the entire list of ingredients before consumption.

Does CBD affect appetite?

Given the low levels of THC, CBD will not typically affect your hunger.
